# **A.** Community Resources Committee

1. <u>Cook Forest Visitors Bureau</u> – Community Resources Committee Chair Clarinda R. Darr suggested Vice-President Hynes write a letter to the Cook Forest Visitors Bureau for funding for Rails to Trails. Community Resources Committee Chair Darr also passed out trail maps and information guides for the Redbank Valley Trails.

## **Borough Manager**

- 1. <u>Light Up Night</u> Manager Schreckengost stated the Brookville Volunteer Fire Company will continue Light Up Night.
- 2. Jefferson County Development Councils Luncheon Manager Schreckengost stated Borough Council Members are invited to attend the 16<sup>th</sup> Annual Jefferson County Development Councils Luncheon being held September 5<sup>th</sup> at 11:30 a.m. at the Beechwoods Restaurant and Lounge in Falls Creek. Manager Schreckengost and President Pro-Tem Allgeier stated they both plan to attend the luncheon.

President Pro-Tem Allgeier suggested Manager Schreckengost ask Tax Collector Vickie Storey and the Borough office staff to see if they are interested in this position, and report back to Council.
